Legal Agreement of Apportionment

APPORTIONMENT of the RENT-CHARGE in lieu of TITHES in the Parish of Ashe in the County of Southampton

Whereas an AWARD of RENT CHARGES in lieu of TITHES in the Parish of Ashe in the County of Southampton, was on the Thirteenth day of March in the Year One Thousand Eight Hundred and Forty four, confirmed by the Tithe Commissioners for England and Wales, of which Award, with the Schedule therein comprised the following is a Copy:-

Know all Men by these Presents That I Thomas James Tatham of Bedford Place Russell Square London Land Agent, having been duly appointed and sworn an Assistant Tithe Commissioner according to the provisions of the Act for the Commutation of Tithes in England and Wales and having also been duly appointed to ascertain and Award the sum to be paid by way of Rentcharge instead of the tithes of the Parish of Ashe in the County of Southampton do hereby award as follows that is to say.

Whereas I have held diverse Meetings near the said Parish touching the matter aforesaid of which Meetings due notice was given for the information of Landowners and Titheowners of the said Parish.

And Whereas I have duly considered all the allegations and proofs tendered to me by all parties interested and have myself made all enquires touching the premised subject which appeared by me to be necessary.

And Whereas I find that certain Lands of the said parish called or Known by the name of Part of South Litchfield Grange Farm of the estimated quantity in Statute measure of Fifty-five acres three roods and thirty nine perches of which Lands John Stephens of Caversham near Reading in the County of Berks Esquire is Owner are covered from render of all Tithes in kind by a prescriptive or customary payment of the annual sum of Ten Shillings and six pence in lieu thereof to the Rector of the said Parish of Ashe.

And Whereas I find that the estimated quantity in Statute measure of all the lands of the said Parish the whole of which are subject to payment of Tithes in kind or to a prescriptive or customary payment in lieu thereof, amounts to Two thousand and sixty-six acres three roods and twenty-eight perches which are cultivated as follows that is to say:-

One thousand six hundred and five acres two roods and twenty-four perches as Arable land.

One hundred and seventy-two acres as Meadow or Pasture.

Two hundred and sixty-two acres as Woodland

Nine acres as Roads and

Eighteen acres one rood and four perches as Railway

And whereas I find that the estimated quantity in Statute measure of the Glebe lands of the said Parish amounts to Thirty-one acres one rood and twenty-seven perches.

And Whereas I have estimated the clear annual value of the said Tithes in the manner directed by the said Act of Parliament and have also taken into account the Rates and assessments paid in respect of such Tithes during the seven years of average prescribed by the said Act.

And Whereas I find that the Rector of the said parish for the time being is entitled to all the Tithes in kind arising or accruing therefrom and also to the prescriptive or customary payment in lieu thereof.

Now Know Ye that I the said Thomas James Tatham Do hereby Award that the annual sum of Four hundred and fifty pounds by way of Rent-charge subject to the provisions of the said Act shall from the first day of October next preceding the Confirmation of the Apportionment of the said Rentcharge be paid to the Rector of the said parish for the time being instead of all the Tithes arising from or accruing due upon all the lands of the said parish subject to the payment thereof in kind (except the Glebe) and also instead of the prescriptive or customary payment in lieu thereof.

And that the further sum of Five shillings per acre and a proportionate sum for any quantity less than an acre shall be paid to the Rector for the time being by way of Rentcharge subject to the provisions of the aforesaid in lieu of Tithes of the Glebe lands of the said parish or of such part of the said Glebe lands as may not at any time be in the occupation of the Rector himself.
