Legal Agreement of Apportionment

APPORTIONMENT of the RENT-CHARGE in lieu of TITHES in the Parish of Bradley in the County of Southampton

Whereas an Agreement for the COMMUTATION OF TITHES in the Parish of Bradley in the County of Southampton, was on the fifteenth day of June in the Year One Thousand Eight Hundred and thirty nine, confirmed by the Tithe Commissioners for England and Wales, of which Agreement, with the Schedule thereunto annexed, the following is a Copy:-

Provisional Articles of Agreement for the Commutation of the Tithes of the parish of Bradley in the County of Southampton pursuant to the provisions of an Act for the Commutation of Tithes in England and Wales made and executed at a parochial Meeting of Landowners and Titheowners duly called and holden in the said Parish on the twenty eight day of September in the year of our Lord One thousand eight hundred and thirty eight and since perfected. By and Between The Reverend John Griffin Rector of the said Parish and as such Owner of all the Tithes there as well Great as Small of the one part and The Several Persons Owners of Land within the said Parish by whom or by whose Agents duly authorized in that behalf these Presents are executed the Interest of Land Owners in the Lands of the said Parish is not less than two thirds of the value of all the Lands therein subject to tithes of the other part.

The Parish of Bradley aforesaid contains by estimation nine hundred and fourteen Acres Statute Measure, the whole of which Land is subject to the payment of all manner of Tithes as well Great as Small in kind and is now cultivated as follows

The Glebe Lands of the said Parish contain by estimation fifteen Acres (more or less) and are exempt from the payment of all manner of Tithes as well Great as Small when in the manurance or occupation of the Rector Himself

The said Glebe Lands are now in the occupation of James Usher and John Snow.

All the Tithes of the said Parish as well Great as Small are payable to the said John Griffin as Rector thereof.

And it is hereby agreed that the annual Sum of One hundred and Eighty five Pounds by way of Rent Charge (subject to the Provisions of the said Act) shall be paid to the said John Griffin and to his Successors instead of all the Tithes as well Great as Small of the Lands within the said Parish subject to Tithes.

And it is hereby further agreed that the annual sum of Four Pounds and fifteen shillings by way of Rent Charge (subject to the Provisions of the said Act) shall be paid to the said John Griffin and to his Successors instead of all the Tithes of the said Glebe Lands when they are not in the manurance or occupation of the Rector himself.

And it is hereby lastly agreed that the Lands included in this Agreement shall be discharged from the payment of Tithes (except as excepted in the said Act) from the first day of October next preceeding the Conformation of the Apportionment of the several Rent Charges hereinbefore agreed on. And that the first payment of such Rent Charges shall be made and be recoverable at the expiration of six Calender Months from the time from which the said Lands are discharged from the payment of Tithes.

In testimony whereof the said Parties to this Agreement or their agents duly authorized in their names and on their behalf have hereunto subscribed and set their hands and seals:-

Now I John Dunn of New Arlesford in the County of Southampton Gentleman having been duly appointed Valuer to apportion the total Sum agreed to be paid by way of Rent Charge in lieu of Tithes, amongst the several Lands of the said Parish of Bradley

Do hereby apportion the Rent Charge as follows: -

Gross Rent Charge payable to the Titheowner in lieu of Tithes for the Parish of Bradley in the County of Southampton (including Tithes of Glebe) One hundred and eighty nine Pounds and fifteen shillings
