Grewell - Tithe Apportionment

Legal Agreement of Apportionment

APPORTIONMENT of the RENT-CHARGE in lieu of TITHES in the Parish of Grewell in the County of Southampton

Whereas an Agreement for the COMMUTATION OF TITHES in the Parish of Grewell in the County of Southampton, was on the Twenty sixth day of September in the Year One Thousand Eight Hundred and forty, confirmed by the Tithe Commissioners for England and Wales, of which Award, with every Schedule therein comprised, the following is a Copy:-

Know all Men by these presents that I, Thomas Smith Woolley of South Collingham in the County of Nottingham having been duly appointed and sworn an Assistant Tithe Commissioner according to the provisions of the Act for the Commutation of Tithes in England and Wales and having been also duly appointed to ascertain and award the Total Sums to be paid by way of Rent Charges instead of the Tithes of the Parish of Grewell in the County of Southampton.

Do hereby Award as follows that is to say:-

Whereas I have held diverse meetings in the said Parish touching the matter aforesaid of which meetings due notice was given for the information of the Land-owners and Titheowners of the said Parish.

And whereas I have duly considered all the allegations and proofs tendered to me by all parties interested and have myself made all inquiries touching the premised subject which appeared to me to be necessary.

And whereas I find that the estimated quantity in statute measure of all the Lands of the said Parish which are subject to payment of any kind of Tithes amounts to Eight hundred and forty-two Acres two roods and six perches which are now cultivated and used as follows that is to say:-

Four hundred and seventeen Acres one rood and thirteen perches as Arable Land.

One hundred and thirteen Acres three roods and thirteen perches as Meadow or Pasture Land

Twenty-eight Acres three roods and twenty-nine perches as Woodland.

Twenty-eight Acres one rood and nineteen perches are the Sites of Houses and Buildings the Yards Gardens and Orchards and the Land covered by Water.

Four Acres and twelve perches are roads and

Two hundred and fifty Acres are the Common Lands of the said Parish.

And whereas I find that all the Lands of the said Parish are subject to payment of all manner of Tithes in kind.

And whereas I have estimated the clear annual value of the said Tithes in the manner directed by the said Act of Parliament and have also taken into account the rates and assessments paid in respect of the said Tithes during the Seven years of average prescribed by the said Act.

And whereas I find that the Chancellor of the Cathedral Church of Salisbury for the time being is the Appropriator and Owner of the Tithes of Corn Grain and Hay arising from all the Lands of the said Parish and that the Reverend John Orde of Winslade in the County of Southampton holds a Lease for lives of the said Tithes under the said Chancellor.

And whereas I find that the Vicar of the said Parish for the time being is entitled to all the Tithes except the Tithes of Corn Grain and Hay arising from the Lands of the said Parish.

Now Know Ye that I the said Thomas Smith Woolley Do hereby Award That the annual sum of One Hundred and Ninety-two pounds by way of Rent-charge subjec to the provisions of the said Act shall from the First day of October next preceeding the Confirmation of the Apportionment of the said Rent-charge be paid to the said Reverend John Orde and to his heirs and assigns during the continuance of the said Lease and from and after expiration or other determination thereof then to the said Chancellor of the said Cathedral Church of Salisbury for the time being and to his successors in the same office instead of all the Tithes of Corn Grain and Hay arising from all the Lands of the said Parish, and that a further annual sum of Sixty-five Pounds by way of Rent-charge subject to the provisions and to commence from the time aforesaid shall be paid to the Vicar of the said Parish for the time being instead of all the Tithes except the Tithes of Corn Grain and Hay arising from all the Lands of the said Parish.

In Testimony whereof I have hereunto set my hand this Twelfth day of September One thousand eight hundred and forty.
