Legal Agreement of Apportionment

APPORTIONMENT of the RENT-CHARGE in lieu of TITHES in the Parish of Laverstoke in the County of Southampton

Whereas AN AWARD of RENT-CHARGE in lieu of TITHES in the Parish of Laverstoke in the County of Southampton, was on the Seventh day of August in the Year One Thousand Eight Hundred and Fifty one, confirmed by the Tithe Commissioners for England and Wales, of which Award with the Schedule therein comprised, the following is a Copy:-

Know all Men by these Presents that I William Wakeford Attree of the Middle Temple Barrister at Law having been duly appointed and sworn an Assistant Tithe Commissioner according to the provisions of the Act for the Commutation of Tithes in England and Wales and having been also duly appointed to ascertain and award the total sum to be paid by way of Rent Charge instead of the tithes of the Parish of Laverstoke in the County of Southampton do hereby award as follows that is to say:-

And whereas I have held divers meetings in the said parish touching the matter aforesaid of which meetings due notice was given for the information of the Landowners and Tithe owner of the said parish.

And whereas I have duly considered all the allegations proofs witnesses and documents made and produced before me by all parties interested and have made all enquiries touching the premised subject that appeared to me to be necessary.

And whereas I find that the site of the Church and the church yard of the said parish containing by estimation one rood and fourteen perches are by prescription or other lawful means exempt from the render of tithes.

And whereas I find that the estimated quantity in statute measure of all the lands of the said parish which are subject to tithes amounts to Two Thousand and one acres two roods and three perches which are cultivated and used as follows that is to say.

One thousand four hundred and ninety five acres one rood and fourteen perches as arable land.

Two hundred acres one rood and thirteen perches as meadow or pasture

Two hundred and eighty seven acres and thirty nine perches as woodland

Ten acres and thirty seven perches are sites of buildings.

And two acres two roods and fifteen perches are garden ground.

And whereas I find that all the lands of the said parish except as hereinbefore mentioned are liable to the payment of all manner of tithes in kind.

And whereas I find that the Rector of the said parish for the time being is entitled to all the tithes arising from or accruing due upon all the lands in the said parish.

And whereas in estimating the clear annual value of the said tithes I have taken into account the rates and assessments paid in respect of such tithes during the seven years of average prescribed by the said Act.

Now Know Ye that I the said William Wakeford Attree do hereby award that the annual sum of One hundred and eighty pounds by way of Rent Charge and subject to the provisions of the said Act shall from the first day of April next preceding the confirmation of the Apportionment of the said Rent Charge be paid to the Rector of the said parish for the time being instead of all the tithes arising from or accruing due upon all the lands of the said parish.

And whereas no part of the said Rent Charge has been awarded on account of any tithes arising from the cottage gardens and holdings of less than a quarter of an acre in extent.

I do hereby further award that no part of the said Rent Charge shall be apportioned on any holding of less extent than a quarter of an acre.

In Testimony whereof I have hereunto set my hand this Twenty first day of July in the Year of Our Lord eighteen hundred and fifty one.
