Legal Agreement of Apportionment

Agreement

APPORTIONMENT of the RENT-CHARGE in lieu of TITHES in the Hamlet or Chapelry of Popham in the County of Southampton

Whereas an AWARD of RENT CHARGES in lieu of TITHES in the Hamlet or Chapelry of Popham in the County of Southampton, was on the Sixth day of May in the Year One thousand eight hundred and forty six, confirmed by the Tithe Commissioners for England and Wales, of which Award with the Schedule therein comprised, the following is a Copy:-

To all whom these Presents may concern, I Francis Offley Martin of Lincolns Inn, an Assistant Tithe Commissioner duly appointed according to the provisions of the Act for the Commutation of Tithes in England and Wales Send Greetings.

Whereas I have held a meetings in the Hamlet or Chapelry of Popham in the County of Southampton for the purpose of Awarding a Rent Charge in lieu of Tithes of the said Hamlet or Chapelry of which Meeting due notice was given for the information of the Land Owners and Tithe Owners.

And Whereas I find that the said Hamlet contains by estimation One thousand four hundred and fifty five acres one rood and four perches whereof:

Nine hundred and five acres three roods and ten perches are Arable.

One hundred and seventy four acres one rood and ten perches are Meadow or Pasture.

Three hundred and five acres and twenty four perches are Wood.

And whereas I find that the Vicar of Micheldever in the said County of Southampton for the time being is the Owner in right of his said Vicarage of the Tithes of Wool. Cheese, Milk, Geese, apples of Orchards and Gardens and one tenth of the Tithe of Lambs arising and renewing on the said Lands

And Whereas I have find that The Right Honourable Lord Ashburton is the Owner of all the Lands in the said Hamlet and being also the owner of all the Tithes arising or renewing on the same (Except those hereinbefore mentioned) has duly merged his said Tithes in the Freehold and Inheritance of the said Lands whereby the same have been absolutley discharged from the payment of all manner of Tithes Except those payable to the said Vicar as hereinbefore mentioned.

Agreement

And Whereas I have estimated the value of the said Vicarial Tithes in the manner directed by the said Acts.

Now Know Ye that I the said Francis Offley Martin Do hereby Award That from and after the First Day of October next preceding the Confirmation of the Apportionment thereof the Annual Sum of Nineteen Pounds by way of Rent Charge, subject to the provisions of the said Acts shall be payable to the Vicar of the said Parish of Micheldever for the time being in lieu of all the Tithes to which he is entitled in the said Hamlet or Chapelry of Pophaam.

In testimony whereof I have hereunto set my Hand this Seventeenth day of April One thousand eight hundred and forty six.
