Legal Agreement of Apportionment

Agreement

APPORTIONMENT of the RENT-CHARGE in lieu of TITHES in the Parish of Steventon in the County of Southampton

Whereas an Agreement for the COMMUTATION of TITHES in the Parish of Steventon in the County of Southampton was, on the thirteenth day of April in the Year One Thousand Eight Hundred and Thirty nine, confirmed by the Tithe Commissioners for England and Wales, of which Agreement, with the Schedule hereunto annexed, the following is a copy:-

Provisional Articles of Agreement for the Commutation of Tithes of the Parish of Steventon in the County of Southampton in pursuance of the Act for the Commutation of Tithes in England and Wales made and executed at a Meeting duly called and holden in the said Parish and adjourned and holden by adjournment on the Fifth day of September in the year of our Lord one thousand eight hundred and thirty eight and since perfected By and between the several persons Owners of land within the said parish by whom or by whose agents duly authorized in that behalf these presents are executed and the Interest of which land owners in the lands of the said parish is not less than two thirds of the lands therein subject to Tithes of the one part and the Reverend William Knight Rector of the said parish and owner of all the Tithes as well great as small thereof of the other part.

It is hereby agreed that the annual sum of Five hundred Pounds by way of Rent charge subject to the provisions of the said Act shall be paid to the said William Knight as Rector of the said parish and to his Successors instead of all the tithes as well great as small of the lands subject to Tithes exclusive of the Glebe the Rent charge in lieu of tithes of which it is hereby agreed shall be affixed at the sum of Twenty two pounds and ten shillings and shall be apportioned exclusively upon the said Glebe lands and insted of all Moduses and Copmpositions real and prescriptive and Customary payments payable in respect of all the lands of the said parish or te produce thereof a Summary description of which lands is contained in the Schedule hereunto written and it is hereby agreed that the said Rent Charge shall commence and take effect on and from the First day of October next preceeding the Confirmation of the Apportionment of the same Rent Charge.

In testimony whereof the said parties to these presents or their respective Agents thereunto duly authorized in their names and on their behalf have to these presents set their respective hands and Seals.

In the above Articles of Agreement, The whole parish of Steventon contains Two thousand and thirty nine acres one rood and seven perches by estimation of which twenty seven acres and eighteen perches, part of the Farm and land of John Stephens Esquire in the said parish that is to say the Piece of Arable Land called Hill field and containing twenty two acres one rood and four perches by admeasurement and the piece of meadow land called the upper meadow and containing Four Acres three roods and fourteen perches by admeasurement is by prescription free from all manner of Tithes and all moduses and compositions real and prescriptive and customary payments whatsoever.

The whole quantity of the Lands of the said parish of Steventon which are subject to the payment of any kind of tithes is one thousand nine hundred and ninety two acres and one rood and nine perches by estimation.

The whole quantity of Land subject to Tithes within the said parish which is cultivated as Arable land is one thousand seven hundred and eight acres and twenty five perches by estimation.

The whole quantity of Land subject to Tithes within the said parish which is cultivated as Meadow or Pasture land is seventy four acres and twenty four perches by estimation.

The whole quantity of Land subject to Tithes within the said parish now cultivated as Wood land is One hundred and Sixty acres estimation.

The Glebe Lands of the said parish which if not in the hands of the Owner or Owners would be subject to Tithes amount to Fifty acres by estimation.

The Roads and Highways within the said parish amount to twenty acres by estimation.

Now I Thomas Hasker of Fareham in the County of Southampton having been duly appointed Valuer to apportion the Total Sum agreed to be paid by way of Rent Charge in lieu of Tithes, amongst the several lands of the said Parish of Steventon.

Do hereby apportion the Rent Charge as follows:

Gross Rent Charge payable to the Tithe owner in lieu of Tithes for the Parish of Steventon in the County of Southampton including Tithe of Glebe Five hundred and twenty two pounds and ten shillings.
