Legal Agreement of Apportionment

Agreement

APPORTIONMENT of the RENT-CHARGE in lieu of TITHES in the Parish of Whitchurch in the County of Southampton

Whereas an AWARD of RENT CHARGES in lieu of TITHES in the Parish of Whitchurch in the County of Southampton, was on the Ninth day of January in the Year One Thousand Eight Hundred and Forty, confirmed by the Tithe Commissioners for England and Wales, of which Award, with the Schedule therein comprised the following is a Copy:-

Know all Men by these Presents That I Thomas James Tatham, having been duly appointed and sworn an Assistant Tithe Commissioner and also been duly appointed to ascertain and award the Total sum to be paid by way of Rent Charge instead of the Tithes of the Parish of Whitchurch in the County of Southampton do hereby award as follows (that is to say).

Whereas I have held a Meeting in the said Parish touching the matter aforesaid of which Meetings due notice was given for the information of the Land Owners and Tithe Owners of the said Parish

And Whereas I have duly considered all the allegations and proofs tendered to me by all parties interested and have myself made all inquiries touching the premised subject which appeared by me to be necessary.

And Whereas I find that the estimated quantity in Statute Measure of all the lands of the said Parish the whole of which are subject to payment of Tithes in kind or to a prescriptive or customary annual payment in lieu thereof, amounts to Six Thousand and Ninety seven acres and Thirty three perches which are cultivated or used as follows (that is to say):-

Five Thousand One Hundred and Twenty one acres One rood and Twenty four perches as Arable Land.

Four Hundred and Twenty three acres Three roods and Two perches as Meadow or Pasture.

Five Hundred and Fifty two acres as Woodland

And Whereas I find that all the Lands of the said parish are subject to the payment of all manner of Tithes in kind.

And whereas I have estimated the clear annual value of the said tithes in the manner directed by the said Act of Parliament and have also taken into account the rates and assessments paid in respect of such tithes during the seven years average prescribed by the

And Whereas I find that the Master for the time being of the house or Hospital of St Cross near the city of Winchester is entitled to all the tithes in kind arising from all the lands of the said parish and that John Portal of Freefolk Priors in the County of Southampton holds a Lease of the said Tithes under the said Master for three lives.

Agreement

Now know Ye that I the aforesaid Thomas James Tatham do hereby award that the annual sum of One Thousand Four Hundred and Thirty six Pounds Sixteen Shillings and Ten Pence by way of Rent Charge subject to the provisions of the said Act shall from the first day of October next preceding the confirmation of the apportionment of the said Rent charge be paid to the said Master and his successors or to the Leesee under him, his Heirs or Assigns instead of all the Tithes arising from all the lands of the said Parish

And that the further the sum of Six Shillings per acre and a proportional sum for any quantity less than an acre shall be paid to the said Master and his successors by way of Rent charge subject to the provisions aforesaid in lieu of the Tithes of the Glebe lands of the said parish or of such part of the said Glebe lands as may at any time not be in the occupation of the said Master himself.

In testimony whereof I have hereunto set my hand this Fourteenth day of December in the Year One Thousand Eight Hundred and Thirty-nine.

Now I Thomas Hasker of Basingstoke and Isaac Williams of Overton in the County of Southampton, Land Surveyor having been duly appointed Valuers to apportion the Total Sum Agreed to be paid by way of Rent Charge in lieu of Tithes, amongst the several Lands of the said parish of Whitchurch

Do Hereby apportion the Rent Charge as follows:-

Gross Rent Charge payable to the Tithe Owner in lieu of Tithes for the Parish of Whitchurch in the County of Southampton (including Fifty four Pounds Eighteen Shillings for the Tithe of Glebe at Six Shillings per Acre). One Thousand Four Hundred and Ninety one Pounds Fourteen Shillings and Ten Pence.
