Legal Agreement of Apportionment

Agreement

APPORTIONMENT of the RENT-CHARGE in lieu of TITHES in the Parish of Winslade and Kempshott in the County of Southampton

Whereas an Agreement for the COMMUTATION OF TITHES in the Parish of Winslade and Kempshott in the County of Southampton, was on the Thirty first day of January in the Year One Thousand Eight Hundred and Thirty-nine, confirmed by the Tithe Commissioners for England and Wales, of which Agreement, with the Schedule hereunto annexed, the following is a Copy:-

Provisional Articles of Agreement for the Commutation of Tithes of the Parish of Winslade and Kempshott in the County of Southampton in pursuance of the Act for the Commutation of Tithes in England and Wales made and executed at a Meeting called and holden in the said Parish and adjourned and holden by adjournment on the Thirtieth day of May in the year of our Lord One thousand eight hundred and thirty-eight and since perfected By and between the several persons Owners of Land within the said Parish by whom or by whose Agents duly authorized in that behalf these presents are executed and the interest of which Landowners in the Lands of the said Parish is not less than two thirds of the Lands therein subject to Tithes of the one part and the Reverand John Orde Clerk Rector of the said Parish and Owner of all the Tithes as well Great as Small thereof of the other part.

It is hereby agreed that the Annual Sum of Two hundred and seven pounds two shillings and sixpence by way of Rent Charge subject to the provisions of the said Act shall be paid to the said John Orde Rector of the said Parish and to his Successors instead of all the Tithes as well great as small of the Lands subject to Tithes (inclusive of Tithes both Rectorial and Vicarial of Glebe the Rent-Charge in lieu of which is hereby agreed shall be fixed at the sum of Two Pounds and eight shillings and which item it is hereby agreed shall be apportioned exclusively upon the said Glebe Lands and instead of all Moduses and Compositions real and prescriptive and customary payments payable in respect of all the Lands of the said Parish or the produce thereof a summary description of which Lands is contained in the Schedule hereunder annexed.

And it is hereby Agreed that the said Rent-Charge shall commence and take effect on and from the First day of October next preceding the Confirmation of the Apportionment of the said Rent-Charge.

In Testimony whereof the said Parties to these presents or their respective Agents thereunto duly authorized in their names and on their behalf have to these presents subscribed and set their respective hands and seals:-

Schedule to the above Articles of Agreement.

The whole Parish of Winslade and Kempshott contains One thousand four hundred and forty eight acres by estimation.

The whole quantity of the Lands of the said Parish of Winslade and Kempshott which are subject to the payment of any kind of Tithes is One thousand four hundred and eighteen Acres by estimation.

The whole quantity of Land subject to Tithes within the said Parish which is cultivated as Arable Land is Seven hundred and forty three Acres by estimation.

The whole quantity of Lands subject to Tithes within the said Parish cultivated as Meadow or Pasture Land is Three hundred and fifty one Acres by estimation.

The whole quantity of Lands subject to Tithes within the said Parish now cultivated as Wood is Three hundred and twelve Acres by estimation.

The Glebe Lands of the said Parish which if not in the hands of the Owner or Owners would be subject to Tithes amount to Twelve Acres by estimation.

Now I William Challis of Basingtoke in the County of Southampton having been duly appointed Valuer to apportion the Total Sum agreed to be paid by way of Rent-Charge in lieu of Tithes amongst the several Lands of the said Parish of Winslade and Kempshott. Do hereby apportion the Rent-Charge as follows:-

Gross Rent Charge payable to the Titheowner in lieu of Tithes for the Parish of Winslade and Kempshott in the County of Southampton, Two hundred and seven pounds two shillings and sixpence.
